

- iii. The Administrative Approval is further subject to the condition that the Executing Agency shall ensure that there is no duplication of work/ payment and shall strictly observe all codal, legal, procedural and financial formalities including audit requirements.
- iv. Executing agency shall ensure that the scheme is in public interest (feasible) and no other executing agencies have undertaken the same scheme in the area.
