The Administrative Approval was accorded by the Departmental Development Sub- Committee vide No. SO. Companies(LG)23-662/2021(PCP) dated 15.07.2021 to the tune of Rs. 230.60 (Million). The case was Re-submitted for Administrative Approval for the revised cost of the said scheme to the tune of Rs.374.023 million before DDSC, in its meeting held on 28.03.2022 and the decision of minutes of meeting received on 13.04.2022 vide No.SO.Companies(LG)23-662/2021(PCP Jaranwala). Administrative Approval accorded by the Departmental Development Sub Committee for the scheme titled above and received vide No. SO. Companies (LG)23-662/2020(P-II PCP) dated 18.04.2022 with a revised cost of Rs.374.023 million.

Accordingly revised estimate of the scheme "Provision of Machinery and Equipment for Improvement of Solid Waste Management in Jhang" is technically sanctioned for Rs.374.023 Million as per decision received from competent authority with following terms & conditions:-

 The Technical Sanction is subject to valid charge, provision of requisite funds, Administrative Approval as per scope and item work provided in the detailed estimate, mutation / transfer of requisite land in the name of department and no complaint / inquiry had been conducted by any Department regarding execution of the Project.

2. The competent authority of the executing agency and the engineer incharge shall ensure that the work is carried out after observance of all financial, codal formalities and strictly in accordance with the sanctioned estimate / specifications of tender accepting authority. The responsibility of the rate shall rest on the authority approving the rates, as the rates provided in the estimate are for estimation purpose only. The tender accepting authority shall also check and satisfy itself regarding quality, durability, economy and lowest market rate in actual before accepting of items to be supplied. The payment shall be made as per quantity of each item of works/actual work executed at site after recording of entries with specification and nomenclature as the quantity of each items of works in

the estimate is for estimation purpose only and shall not confer to authority for its payment.

The non-schedule rates as contained in the estimate are for estimate 3. purpose only and should not be taken as authority for making paym The payment of such item will also be made after getting compe rates after observing of all financial and codal formalities.

Purchases of vehicles chassis, HR cost for operation of Solid w Machinery, Monitoring and vehicles tracking system are included in 4. estimate, but it does not fall in the orbit of technical sanction, so matter pertain to these items may be dealt accordingly.
