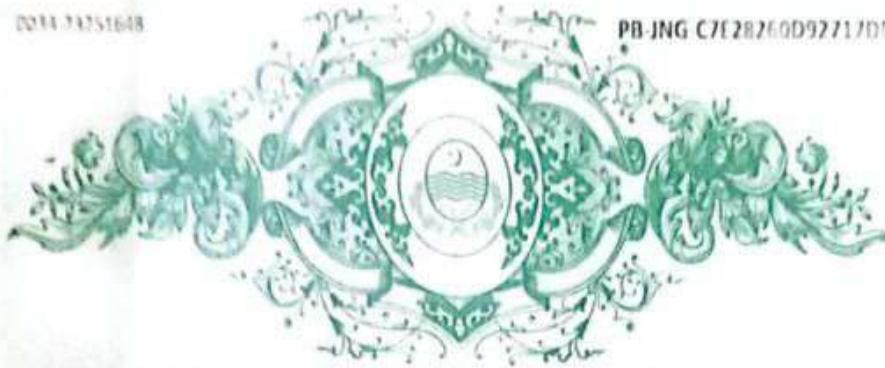

In consideration of the covenants and agreements to be kept and performed by the contractor and for the faithful performance of the contract and the completion of works embraced therein, according to the specifications, drawings and conditions herein contained and referred to the Government shall pay and the contractor shall receive and accept as full compensation for everything furnished and done by the contractor under this agreement and the Bid price stipulated in the contractor's Bid at the times and in the manner prescribed by the contract. The contractor will be bound for obeying the condition mentioned in work order.

The said work shall be started within the period specified in item No.(d) of the memorandum of work, following the receipt of written order of the Chief Officer Municipal Committee Jhang to proceed with and the contractor shall complete fully the works within the stipulated period starting after one month of the date of issue of letter of award, subject to such extensions of time as may be granted under the conditions of contract except for removal of defects if any which shall be completed within the period specified in item No.(e) of the memorandum hereto annexed after issuance of the final certificate of completion.

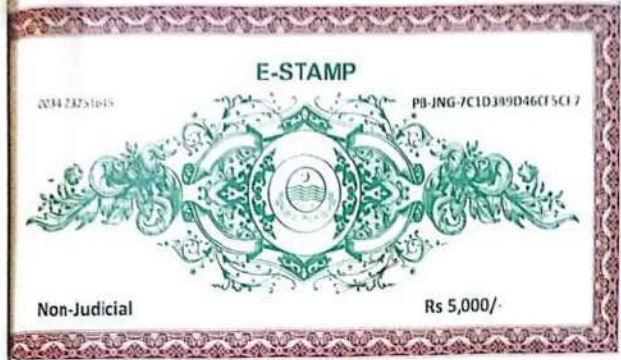
